Election: Candidates are solicited from stakeholder organizations/associations. The Slate of Nominees is presented by CIMRO of Nebraska to the Corporate Member, CIMRO, for election to the CIMRO of Nebraska Board. Directors are typically elected in March (unless a vacancy exists) and commence Board service at CIMRO of Nebraska's Annual Meeting held in May.

Terms: By-Laws provide for staggered terms so that one-third of the Board is elected each year. Directors are elected to three year terms. By-Laws require in no event shall more than three Directors serve for more than six consecutive years on the Board. No Director may exceed nine consecutive years of Board service. Upon reaching a term limit, a Director may be re-elected after a one year break in Board service.

Board Compensation: Reflects the amount paid for attendance and participation in Board of Director and Board Committee meetings during calendar year 2009. Excludes reimbursable travel expenses.
